# **EC-Zonal Coordinators Meet**

As part of AHPI Tamil Nadu's first Executive Committee and Zonal Coordinators meet, Dr O V Nandimath, Professor of Law and Chair Professor at NLSIU, Bengaluru, addressed the pressing challenges faced by healthcare providers in Tamil Nadu related to private insurance — including disallowances, delayed disbursements, lack of transparency, and unfair recovery practices. Dr Nandimath emphasized the importance of collecting structured, evidence-based data across member hospitals to highlight the systemic issues. He also urged the need to push for transparency. The session was highly interactive and offered practical legal strategies to strengthen the collective voice of healthcare providers through AHPI-TN.
